Before first use

- 1. Remove any labels and/or swingtickets.
- 2. Follow the cleaning instructions see "Cleaning and Care".

How to use the Can Opener

The Can Opener should be sited on a dry, level and stable surface, away from direct heat. The Mains Lead (1) should be positioned so as not to cause an obstruction or to overhang the edge of the surface.

1. Angle the Blade Assembly ② with the 'PRESS' button tilted upwards. Align Locating Post A ④ with Hole A ⑤ and Locating Post B ⑥ with Hole B ⑦ then push the Blade Assembly ② inward towards the Blade Assembly Mounting ③.

THE BLADE IS VERY SHARP. TAKE GREAT CARE WHEN HANDLING THE BLADE ASSEMBLY.

2. Plug the Mains Lead ① into a mains socket and switch on; please read the CAUTIONS on siting and connecting to your mains electricity.

Do not use the can opener to open cans that are intended to be opened by other means, such a ring pull or rotating key. The can opener will not open rimless cans or cans with angled corners.

- 3. Position the Can (A) (see diagram below) against the body of the Can Opener, so that:
- ✓ the top of the can rim is in contact with Locating Post B ⑥,
- ✓ the bottom outer edge of the can rim is in contact with the Toothed Wheel B,
- ✓ the can lid is in contact with the Magnet © and
- ✓ the Blade

 is in contact with the can lid, on the inside of the can rim.





You should find that you are able readily to position the can as described and that it remains in place, so that there is no need to support it by hand. If the can is not held in place by the mechanism, adjust its position as necessary. You may need to support the Can Opener Body ① when opening a large or heavy can.

4. Press down on the Blade Assembly Button (E), until the Blade Assembly (2) is below the horizontal position, so that the Blade (D) pierces the can lid and the Can Opener motor switches on.

The can will rotate as it is opened by the Can Opener, until the lid is fully removed. The Blade Assembly ② will return to the horizontal position, the lid will be held by the magnet and the can will be supported by the Can Opener mechanism. The magnet will not hold aluminium or other non-ferrous can lids. If there is a dept in the rim of the can

If there is a dent in the rim of the can, open the other end (if suitable) or start the cutting action just beyond the dent. Cans with heavy seams, uneven rims or odd shapes may cause the can opener to stall; if this occurs, turn the can slightly by hand to aid the cutting action.

 Remove the lid from the magnet and dispose of the lid. Grasp the can, then lift the Blade Assembly ② slightly to release the can, which can now be withdrawn.

THE CAN AND LID WILL BOTH BE SHARP. HANDLE AND DISPOSE OF WITH CARE.

6. Switch off at the mains and unplug the Mains Lead (11) from the socket.

Do not use the can opener to open pressurised cans or cans containing flammable liquids.

Do not open more than five cans in succession; allow a 15-second break after five cans.

How to use the Bottle Opener

- Ensure the Can Opener is disconnected from the mains supply.
- 2. Support the body of the Can Opener with one hand and insert the neck of the bottle into the Bottle Opener ® (see diagram).
- 3. Move the bottle body downwards with a swing action to remove the cap from the bottle.
- 4. ENSURE THAT THE TOP EDGE OF THE BOTTLE OPENER IS IN CONTACT WITH THE EDGE OF THE BOTTLE CAP, NOT THE BOTTLE NECK, OR THE GLASS MIGHT BREAK.



How to use the Knife Sharpener

- 1. Ensure the Can Opener is disconnected from the mains supply.
- 2. Wash and dry the knife to be sharpened.
- 3. Support the body of the Can Opener with one hand and insert the knife blade into the Knife Sharpener (10) (see diagram).
- 4. Draw the knife blade through the knife sharpener slot, for the full length of the blade, in either direction, until you achieve the desired sharpness.
- 5. Wash and dry the sharpened knife.

TAKE CARE WHEN HANDLING THE KNIFE AFTER SHARPENING.
DO NOT ATTEMPT TO SHARPEN SERRATED BLADES. AS THIS WILL

REMOVE THE SERRATION. DO NOT ATTEMPT TO SHARPEN SCISSORS.

Cleaning & Care

Ensure the Can Opener is disconnected from the mains before cleaning.

- Wash the Blade Assembly ② in liquid detergent and warm water, then allow to dry.
 THE BLADE IS VERY SHARP. TAKE GREAT CARE WHEN HANDLING THE BLADE ASSEMBLY.
- 2. Wipe the inside and outside of the Can Opener Body ① with a cloth slightly dampened with liquid detergent and warm water. A scourer can be used with the liquid detergent solution to remove stubborn spots.

Do not use harsh abrasive cleaners.

3. When the Can Opener is not in use, store in a dry place. The Mains Lead ① can be pushed into the Cable Storage ②.
